



## **New Faculty Award**

The Old Dominion University Alumni Association invites nominations for candidates for the third year of the New Faculty Award. This award seeks to recognize members of Old Dominion's non-tenured faculty who have demonstrated outstanding achievement in teaching, discovery, knowledge integration, and service. The New Faculty Award looks to acknowledge well-rounded faculty members who embody the balance of all four areas through his or her work at Old Dominion University.

### **Eligibility**

Nominees must be Old Dominion University full-time faculty members: lecturers, instructors, or assistant or associate professors. Having already provided no more than five years of continuous service as a full-time faculty member, a nominee must be in at least his or her second year of continuous faculty service at Old Dominion University.

Those nominees not selected for the award in 2016 may be considered for a subsequent year's award based on the completion of an updated nomination package.

All nomination packets must be completed and delivered to the Office of Alumni Relations no later than March 2, 2016 at 5:00 P.M.

### **New Faculty Award Information**

The awardee of the New Faculty Award will receive a framed certificate of achievement, a \$500 award, and a non-reserved parking decal for one year. The certificate will be presented to the awarded faculty member at the annual Faculty Awards Ceremony held each spring. It acknowledges the recipient's achievement and excellence in teaching, discovery, knowledge integration, and service in their work at Old Dominion University.

The recipient of the New Faculty Award will automatically be placed into consideration for the SCHEV Rising Star Award later in the year. The Rising Star is intended to acknowledge faculty members showing extraordinary promise at the beginning of his or her academic career. If your nominee is selected as one of the University's nominees for the Rising Star SCHEV award, another nomination form specific to the Rising Star Award will be required at a later date.

## Nomination Package Requirements – New Faculty Award 2016

Page 1: *Cover Sheet* – Please complete the provided cover sheet and submit as first page of nomination.

Page 2: *Excerpts from Mission Statement* – Please provide five or six sentences of ODU’s Mission Statement that most accurately capture ODU’s core mission. This section must not exceed *one-half of a single page*.

Page 3-8: *Summary of Accomplishments* – Identify and briefly describe major highlights of the nominee’s record of accomplishments which directly address the nomination criteria. The summary may be prepared using bullets (complete sentences are not required). Third person perspective is recommended. The amount of attention given to each area of scholarship (teaching, discovery, knowledge integration, and service) should be reflective of the nominee’s employment responsibilities and ODU’s mission. This section must not exceed *six pages*.

Page 9-10: *Personal Statement* - The nominated party must prepare a personal statement that addresses the following areas: the distribution of his or her faculty responsibilities across Boyer’s four areas of scholarship; his or her educational philosophy; and any other information the nominee considers relevant. Please avoid restating information discussed in the summary section. First-person narrative utilizing complete sentences is recommended. This section must not exceed *two pages*.

Page 11-12: *Abbreviated Curriculum Vitae* - Please provide an abbreviated curriculum vitae that outlines the nominee's education; teaching experience; scholarly works and activities; public and academic service; awards; and other significant contributions. This section must not exceed *two pages*.

Page 13-15: *Letters of Support (Excerpted)* – Please provide excerpts of support letters from supervisors (dean, department chair, etc.); colleagues (institutional and/or disciplinary); students (former and/or current); and/or community leaders or members. There is no maximum number of letters to be included but this section must not exceed *three pages*.

Page 16-19: *Additional Documentation* – Please submit any additional relevant documentation and/or evaluation of the nominee's teaching (e.g., summaries of student and/or peer evaluations), scholarship, knowledge integration, and service. Objective (quantitative) information is encouraged. This section must be submitted typewritten and must not exceed *four pages*.

\*\*\*Please submit a photo (jpeg preferred) of the nominee with the nomination packet.

Nomination submissions must be prepared using:

- Standard 8.5x11-in. page size
- Standard 20 lb. stock paper
- Standard one-inch margins
- At least single spacing
- Size 11 font in Arial font style

***The nominator is responsible for providing one electronic copy and one physical copy including all supporting materials.***



**Nomination Criteria** – Based on the Virginia Outstanding Faculty Awards established criteria

1. A nominee must possess a record of superior accomplishment that strongly reflects Old Dominion University's mission.

2. A nominee must possess a record of superior accomplishment in the four areas of scholarly endeavor described in Ernest Boyer's *Scholarship Reconsidered* (1990, Jossey-Bass): teaching, discovery, integration of knowledge, and service. A nominee will be judged in each of these four areas within the context of Criterion #1.

a. A record of superior accomplishment in the scholarship of ***teaching*** should contain clear and compelling evidence related to instruction and student development and learning.

b. A record of superior accomplishment in the scholarship of ***discovery*** should contain clear and compelling evidence related to scholarly works (objective, subjective, and/or artistic) and scholarly activities (new knowledge and research).

c. A record of superior accomplishment in the scholarship of ***knowledge integration*** should contain clear and compelling evidence related to curricular development, including placing the nominee's discipline in larger interdisciplinary and cross-disciplinary contexts and meaningful connections between a nominee's discovery and teaching.

d. A record of superior accomplishment in the scholarship of ***service*** should contain clear and compelling evidence related to the application of knowledge and expertise in the broader contexts of ODU, the community and/or society, and professional service.

3. A nominee's record of superior accomplishment must demonstrate clear and compelling evidence of the nature, level, and/or degree of a nominee's:

- involvement/ participation;
- effectiveness/success;
- impact/achievement; and
- recognition/acknowledgement in the areas of teaching, discovery, knowledge integration, and service.

The nature, level, and/or degree of this evidence must also be reflective of ODU's mission.

Each of the sections may not exceed the maximum page limit.**

**Please do not include personal information on any page with the exception of the cover sheet.**
